A. Jail Update – *John McGarva reported a total of 103 in custody at LCJ. 43 sentenced, 29 males sentenced, 15 females sentenced, 60 non-sentenced, 51 male non-sentenced, 8 female non-sentenced, 14 1170h. The jail is implementing LFMT – Art Expression and a Chess Program. John reported they will have 20 Chess sets donated to the jail. To date, they have had 120 graduates. John also reported they are preparing for the PREA Audit.*

B. Cal-Aim/Care Court – *Danielle Sanchez reported out on Behavioral Health Information Notice No: 22-059 - \$26 million was appropriated to be distributed to Cohort 1, the remaining \$31 million was appropriated to be distributed to all counties and the City and County of San Francisco. See attachment. John McGarva reported he is waiting on financial information from HSS Fiscal. Danielle reported HSS Fiscal will be closed for the next 5 days. Round 2 application is due December 31st.*

D. Probation/DRC Updates – *Jennifer Branning reported the Program Manager position is currently re-flying. Jennifer Miller reported that Probation recently conducted compliance checks. Out of the 5 scheduled, 2 were completed. Neither of which led to an arrest, no contraband was found. Probation staff are continuing to write Court Reports and file with the Courts. No changes or updates in the DRC/VIBE Program.*
