Jail Update Amy Foster reported a total of 98 in custody at LCADF. 28 sentenced, 12 males sentenced, 16 females sentenced, 70 non-sentenced, 59 male non-sentenced, 11 female non-sentenced, 9 1170h and 3 inmates awaiting transport to prison. Amy reported the high school education programs will begin next week in the jail. Amy reported they are currently working on the 504 yard to expand as they are overcrowded in the jail. Amy also reported the freezer in the kitchen broke.
- B. Cal-Aim/Care Court First cohort starts October 1st.. Glenn county will be in the first cohort, and they are the most similar in size to us. Lassen County's plan is not done yet. Barbara reported NGO's can be included. Barbara mentioned an article posted on the 20th from Judge Cousins. Barbara reported part 2 applicant for Cal-Aim is under review and we have 180 days to submit a plan for part 3.
