RESOLUTION OF THE BOARD OF SUPERVISORS, COUNTY OF LASSEN, STATE OF CALIFORNIA CALLING FOR, AND AUTHORIZING THE SUBMISSION TO THE VOTERS OF AN ADVISORY QUESTION REGARDING INDOOR CANNABIS CULTIVATION SITES IN THE UNINCORPORATED AREA OF LASSEN COUNTY, AND CONSOLIDATING THE ELECTION WITH THE NOVEMBER 8, 2022, CONSOLIDATED GENERAL ELECTION

WHEREAS, there are no legally permitted indoor commercial cannabis cultivation sites in the unincorporated area of Lassen County, and;

WHEREAS, an ordinance has not been enacted by the Lassen County Board of Supervisors for the purposes of permitting and regulating indoor commercial cannabis cultivation sites in the unincorporated area of Lassen County, and;

WHEREAS, a county may hold, at its discretion, and advisory election to receive an indication of general voter opinion for the purpose of allowing voters in the county to voice their opinions on substantive issues and the results of the advisory vote will in no manner be controlling on the Board of Supervisors, as provide for in California Elections Code section 9603 et. seq.

NOW, THEREFORE, BE IT RESOLVED, BY THE Board of Supervisors of Lassen County, that:

Section 1. The foregoing recitals are adopted as findings by the Board of Supervisors as though set forth fully herein.

Section 2. The Board of Supervisors hereby calls an election to be held and conducted in and for the County of Lassen on Tuesday, November 8, 2022, for the purpose of submitting an advisory question to the electorate.

Section 3. At said Advisory Election, the question to be submitted to the voters shall be presented in the following manner:

ADVISORY VOTE ONLY

Shall the Board of Supervisors of the County of Lassen consider enacting an ordinance for permitting and regulating legally permitted commercial indoor cannabis cultivation sites in the industrially zoned unincorporated areas of Lassen County?

Section 4. The Lassen County Clerk as the Ex-officio Register of Voters is hereby directed to prepare and conduct all functions for the election and canvass the returns of the election as set forth in the Election Code, and to do all things required by law to present the proposed Advisory Measure to the electorate, including but not limited to, preparing and publishing all required postings, notices and fillings.

Section 5. Pursuant to Elections Code section 9160(b), the Board of Supervisors hereby directs the County Counsel to prepare an impartial analysis of the proposed Advisory Measure. Arguments for and against Advisory Measure may be filed and published consistent with Elections Code section 9162, et seq.
