- A. Jail Update John mentioned population CDC closed intakes into prisons, reopen of February 1st. Currently 3 inmates pending for prison. Laundry equipment has been installed. Transport van is back and in service. Didisse and McGarva to attend correctional seminar. J Rule is the new Program Coordinator. LFS is in teaching parenting classes. CPS is working on doing video visits for reunification. Education program is back on with the new semester. Currently working on getting scannable wristbands for inmates, this will create paperless/electronic checks. Public Works is working on a new HVAC system. DSH reached out to decrease the backlog. reevaluation in custody to get this restored. DSH to look at old JDF March 9th for evaluation of the facility. Looking into getting a garden set up for a project at the jail. Will look into costs and needs.
- **B.** Data Update *Linsay updated on VIBE Program. 6 classes completed since creation.* 9 total graduates, 3 clients graduating from 4 or more classes. 2 clients successfully terminated while enrolled. Positive feedback and participation from clients. 3 referrals to outside resources to clients enrolled. Only 1 VOP while a client was enrolled. More classes this year.
- C. Probation/Day Reporting Center Update Jennifer mentioned Tiffany, Barbara, and herself working on the population with mental health issues going through the jail and juvenile hall due to those mental health issues, some conserved with Barb, some on probation. There is no placement for these individuals. The question is, what is the

state going to do to help? Data Driven Recovery Project with K. O'Connell is finding data points that overlap clients in these departments. These findings will be brought to the CCP to help better serve those populations. Position of Program Services Manager is flying, so that the programs may be stabilized.
