- Use only black pen to mark the ballot
- Blacken the oval () completely
- Remember to check both sides of the ballot
- Do not vote for more than the number of candidates to be elected for each office
- If you make a mistake in marking your ballot, cross out the incorrect mark and write "ok" next to your correct choice. DO NOT sign or initial your ballot. You may request a new ballot at the Historic Courthouse, 220 S. Lassen St. #5, Susanville, CA 96130

TO RECORD YOUR VOTE:

- ◇ Tear off your ballot stub
- ◇ Place in return envelope
- ◇ Return to Election Official/Election Office
- ◇ **DO NOT** deface or tear the ballot in any way
- ◇ **IF MAILING BALLOT**, postmark by Election Day **OR** Return to any polling location on Election Day
- ◇ **SIGN YOUR ENVELOPE, YOUR VOTE IS NOT VALID WITHOUT IT**

INSTRUCTIONS TO VOTERS:

1. To vote you must completely darken the oval ● next to the candidate or measure of your choice. If you mismark an oval or change your mind, exchange your ballot for a new one.
2. To write-in a name, you must completely darken the oval ● to the left of the line provided and write the name on the line.
3. All distinguishing marks or erasures are forbidden and make the ballot void.

Voter-Nominated and Nonpartisan Offices

All voters, regardless of the party preference they disclosed upon registration, or refusal to disclose a party preference, may vote for any candidate for a voter-nominated or nonpartisan office. The party preference, if any, designated by a candidate for a voter-nominated office is selected by the candidate and is shown for the information of the voters only. It does not imply that the candidate is nominated or endorsed by the party or that the party approves of the candidate. The party preference, if any, of a candidate for a nonpartisan office does not appear on the ballot.

- Ballots returned by mail are the first votes to be counted at 8 PM on Election Night.
- If you choose, you may deliver your ballot in person to the Historic Courthouse, 220 South Lassen Street, Suite 5, Susanville, anytime during business hours (9 AM to 12 PM and 1 PM to 4 PM, Monday through Friday, excluding holidays).
- You may also drop off your ballot at any polling location in Lassen County on Election Day from 7 AM to 8 PM. For a list of locations visit our website at www.lassencounty.org or call the election office at 530.251.8217.

WHO MAY VOTE BY MAIL? Any registered voter may apply for and vote their ballot by mail, making "vote-by-mail," accessible to everyone.

HOW DO I APPLY FOR A VOTE-BY-MAIL BALLOT? On the back cover of this booklet is an application to receive a Vote-by-Mail ballot. Simply sign the application, fill in the other required information and drop it in the mail or return it in person.

HOW DO I VOTE MY BALLOT? Follow instructions which accompany your ballot.

REMEMBER TO SIGN YOUR RETURN ENVELOPE: The Election Official must compare your signature to your registration card to determine and verify that you are the authorized voter.

MAIL EARLY: Your envelope must be postmarked by the Post Office no later than Election Day, **Tuesday, June 4th, 2019**, and received by the Election's office within three days after the Election.

NOTICE TO THE PHYSICALLY DISABLED VOTER:

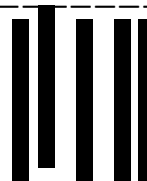
If the polling place is not accessible to the physically disabled voter, such voter is entitled to vote in one of the following ways: A precinct board member may take a regular ballot to the physically disabled person at a place as near as possible to the polling place and which is accessible to such person, qualify that person to vote, and return the voted ballot to the polling place; or if it is impractical to vote a regular ballot outside the polling place, please use attached application and apply for a Vote-By-Mail ballot.



Any voter may apply to permanently Vote-By-Mail in accordance with California Elections Code Sections 3001 & 3201. An application is located on the back of this booklet.

VOTE BY MAIL VOTING INFORMATION

MAY 6th 2019	First day to request a Vote By Mail Ballot	PERMANENT VOTE BY MAIL STATUS: Any voter may apply for Permanent Vote By Mail ballot status per Elections code Section 3201, by completing the written request form and checking the box on the back of this Voter Information Guide and Sample Ballot.
MAY 20th 2019	Last day to register or update address this election	If you moved within the same county, you may vote on Election Day at your new address or at the office of the County Clerk. HOWEVER , you must register at your new address to vote in future elections. These voters must vote a provisional ballot in this election.
MAY 28th 2019	Last day to request a Vote By Mail Ballot	You must be a registered voter in this county. Make a separate request for each election or request to be a permanent Vote By Mail Voter on the reversed side of this form. Sign your request in your own handwriting. Submit your request to the County Clerk's office no later than 5 PM on the date shown (the 7th day prior to Election Day).
JUNE 4th 2019	Last day Vote By Mail Ballot can be accepted for counting	Vote By Mail ballots must be postmarked by Election Day and received 3 days after the Election, OR any polling place in Lassen county no later than 8 PM on Election Day. A voter who is unable to return his/her ballot, may designate his or her spouse, child, parent, grandparent, grandchild, brother, sister or person who resides in the voter's household to return the ballot.

NOTICE REGARDING APPLYING FOR A VOTE BY MAIL BALLOT

If you find that for any reason you will be unable to vote in person on election day, promptly complete and sign the application for a Vote By Mail ballot printed above and return to

PERMANENT VOTE BY MAIL VOTER STATUS

State law now allows any voter who so requests to be a Permanent Vote By Mail Voter. If you check the Permanent Vote By Mail box on the Application for Vote By Mail ballot, a ballot will automatically be sent to you for future elections. Failure to vote in two statewide elections will cancel your Permanent Vote By Mail status and you will need to reapply.

ASSISTANCE FOR THE VISUALLY, HEARING, OR SPEECH IMPAIRED

CA Secretary of State's office has a TDD (Telecommunications Device for the Deaf) for election information: 1-800-833-8683 (1-800-TDD-VOTE). For the visually impaired, audio tapes of State Ballot Measures are available from the County Clerk's office.

In an effort to update the voter rolls and reduce waste, the County of Lassen intends to implement provisions of elections Code Section 2224 which allows the County elections office to send a notice to voters who have not voted in any election in the past four years **AND** who have not updated their registration during these four years. The notice asks the voters if they still live at the address where they are registered to vote. Voters who have neither voted in any election not updated their registration during the past four years but who return the notice with an affirmative response will remain on the active list of registered voters. Such voters who **DO NOT** respond affirmatively will be placed on the inactive voter list, and they will no longer receive election materials.
